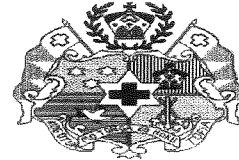


FANONGONONGO

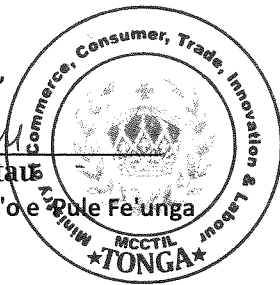

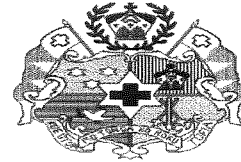
