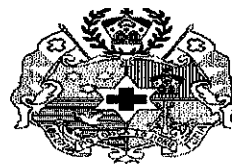


**NOTIFICATION**

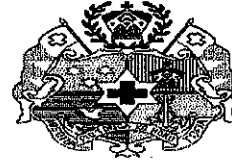
